

Invitation of Quotation for providing of Generator on Rental Basis

Quotations are invited from interested Individual/Vendor/Firm for providing 45KVA Green/Silent Generator to proposed Head Office of Assam Gramin Vikash Bank, at Adam's Plaza, Christianbasti, Guwahati-05, on monthly hiring basis.

Technical specifications of the Generator to be installed:

Nominal Rated Capacity	45 KVA (minimum)
Brand	Any of the following reputed Brand: Cummins/Kirloskar/Geraves/Mahindra/Ashok Leyland /Crompton Greaves /Honda
Description	In any case, the DG set should be ISO certified/ISI marked. It should be sound proof and weather proof. It should also conform to the statutory government noise level norms. Pollution norms in the area must be complied with by Vendor and document in this regard will be submitted
No of Phase	Three Phase
Type of Engine cooling	Liquid Cooled
Fuel	High Speed Diesel (HSD)
Overload capacity	10% in excess of rated KVA
Hours of service	Upto 24 Hours per day

Eligibility of the Supplier/Vendor:

- I. The Individual/Vendor/Firm must be a permanent resident of the State of Assam with no criminal records/cases pending in his/her name.
- II. The Aadhaar card, PAN card and other valid government ID proof/Address proof duly self-attested & GST Registration certificate to be submitted along with other relevant documents.
- III. Individual/Vendor/Firm should not be defaulter of bank's loan/ government agency.
- IV. Individual/Vendor/Firm should be able to provide manpower during working hours for looking after DG set & should possess the adequate technical skill for running the generator sets.
- V. Individual/Vendor/Firm should be financially sound i.e. capable of providing services at their own cost.
- VI. The supplied Gen set must be brand new and in excellent working condition.
- VII. All expenses in regards to placing & installation, Fuel & Lubes, Servicing, Repair & Maintenance, manpower, licence/permission related fee etc. to be borne by the vendor.
- VIII. The Individual/Vendor/Firm must keep the generator insured and documents updated at his/her own cost.
- IX. The initial agreement period shall be of 03 years. However the bank may terminate the agreement at any point of time during the agreement period by serving one month notice with/without citing reason thereof.
- X. Individual/Vendor/Firm having experience in providing generator service to Banks/Govt. Offices/Reputed Pvt. Institutes and Offices will be preferred.

Willing Individual/Vendor/Firm fulfilling above specifications, terms and condition are requested to submit quotations in plain paper/letter head application specifying the quoted monthly rent along with relevant documents, in sealed envelope addressed to 'The General Manager, Assam Gramin Vikash Bank, Head Office, Bhangagarh, Guwahati -05', superscripting "Quotation for Providing Generator service on Rental Basis for AGVB Head Office at Adam's Plaza, Christianbasti, Guwahati". The Individual/Vendor/Firm must also mention their name, complete address and contact details. The decision of the Bank will be final and binding.
